Minutes of the Academic Council Meeting - 10th August 2024.

Agenda No 1: Welcome and Introduction of Members

Proceeding: Principal Dr. Shaila Bootwala introduced and welcomed the two new Members of the Academic Council nominated by the Governing Body:

1. Dr. Sonali Jadhav- Principal AISSMS College of Hotel Management and Catering Technology, Pune

2. Dr. Saleem Shaikh, Associate Professor, A. K. Khan Law Academy, Pune.

Mrs. Gauri Devasthale, Member Secretary informed that Dr. Pardeshi has communicated his inability to attend the meeting as he is travelling.

All other members were present in Person.

Agenda No.2: To approve the minutes of meeting held on 30.01.2024.

Proceeding: Dr.Munira Lokhandwala read the minutes of the meeting held on 30.01.2024. The same were approved.

Agenda No.3: To ratify the nominations of the subject experts from outside the Savitribai Phule Pune University nominated on the various Board of Studies of the College.

Proceeding: Mrs. Gauri Devasthale presented the list of the various Boards of studies along with the Academic council nominations from university other than SPPU. She also pointed out that the 13 boards have members from 15 different universities which will enable the college to have valuable suggestions and inputs in restructuring the syllabus of various courses. All the nominated subject experts were approved by the Academic Council.

Agenda No. 4: To Scrutinize and approve the Syllabi of the following programs recommended by the various board of studies, together with the program structure and suggested methodologies for teaching and evaluation to be introduced from the Academic Year 2024-25 for UG and PG.

Proceeding: The Dean of the Faculty of Humanities: Dr. Wahida Shaikh, The Dean of the Faculty of science: Dr. Khursheed Ahmed, The Dean of the Faculty of Computer Science: Mrs. Shakila Siddhavatam and The Dean of the Faculty of Commerce and Management:

Dr. M.G. Mulla presented the details of the program structure, papers in major, minor, VEC, IKS and OE and their syllabus approved by the BoS along with the percentage of change introduced under the NEP pattern.

The efforts of the staff, BoS chairpersons and Deans were highly appreciated by the Principal and other members.

Agenda No. 5 : To approve the Grant of Provisional admission on the same lines as University Circular No 197/ 2023 dated 6/9/23 and Circular No Exam/ S&T/ 268 dated 16/02/24

Proceedings: Dr. Aftab Alam, Controller of Examinations

Dr. Aftab Alam presented the proceedings of the meetings of the Board of examination and Board of Deans in support of the Provisional admission given to students. Considering the transition from SPPU to Autonomy and autonomy to NEP post COVID 19, the provisional admission clause was accepted.

Agenda No. 6: To ratify the admission of students under equivalence as decided in the Board of Examination along with the deans held on 25th June 2024.

Proceedings: Dr. Aftab Alam, Controller of Examinations presented the proceedings of the meetings of the Board of examination and Board of Deans held for considering the equivalence of students seeking admission from SPPU CBCS pattern to Autonomy 2021 pattern and/or Autonomy 2021 pattern to NEP 2023 pattern. He also presented one case of how equivalence was reflected for Major, Minor and other papers. He further explained that although NEP considers equivalence on credit basis, the Deans constituted a faculty wise committee for checking equivalence of every student so that the students should not face an academic loss. This idea was highly appreciated.

Agenda No. 7: To recommend the commencement of M.Sc. in Biochemistry, M.Sc. in Pharmaceutical Chemistry and Ph. D. in Urdu from the Academic year 2025-26.

Proceedings: Dr. Khursheed Ahmed, Dean Faculty of Science stated that the admissions for traditional PG courses are not satisfactory. Hence courses with more demand need to be introduced. Also, Principal Dr. Bootwala stated that the Deccan Muslim Institute which had facility for Ph.D. in Urdu has closed down and to accommodate the students registered therein the college would like to start a Ph.D. center in Urdu.

Agenda No. 8: To recommend the commencement of an additional Division of B.Sc. Computer Science and B.Sc. (CA) from the Academic Year 2025-26.

Proceedings: Dr. Shaila Bootwala mentioned the increase in demand for computer based courses from students. Considering the number of applications for admission, the college would like to add one more division for the above mentioned courses.

Agenda No. 9: Any other matter with the permission of the chair.

Proceedings:

i) Principal Dr. Shaila Bootwala informed the Academic council that the term of the VC nominees of the previous academic Council was completed and the college has communicated with SPPU regarding the same. Three letters were sent in February, June and July followed by six physical visits by Dr. Mulla. However the University Authorities have not sent the names of VC nominees for the college academic Council. Considering the Autonomy regulations 2023 issued by UGC, the meetings of the statutory bodies have to be held every six months. Thus the college had to conduct the Academic Council meeting without the VC nominees.
ii) Dr. Bootwala also proposed to start a PG diploma in Data Science and AI for the

PG students across all faculties and UG students of the science faculty. She suggested that this would boost the admissions and attract more students for PG programs.

The Meeting concluded with a vote of thanks by Mrs. Gauri Devasthale.
